Mr. Koogler reported that the number of positive COVID cases continues to decrease in various areas of the County based on the State of Ohio zip code dashboard.

He suggested that a master plan for future needs be put together for that facility. He said the County Commissioners Association of Ohio is looking at the requirements needed for a County Engineer. He would like to have a work session scheduled to discuss the proposed changes and have the Board come to a consensus on where they stand. Mr. Perales said he visited the COVID vaccine site set up at Russ Research Center. He thanked Ohio University for allowing the use of the site and thanked the volunteers and Greene County Combined Health for their hard work in administering the vaccine. Mr. Perales said he had a conference call with an Under-Secretary of the Pentagon and the Dayton Development Coalition Pentagon Liaison, Michael Gessel, to discuss what, if anything, is expected from the new Administration. He said there is no one named Secretary of the Air Force, yet. They also discussed what Wright-Patterson Air Force Base can do to enhance this area for future growth.
