**NOTICE OF REGISTRATION
OF FOREIGN PARENTING

In accordance with O.R.C. 3127.35, you are hereby advised that a Petition for Registration of a Foreign Custody Order from the State of _____ has been filed with this Court, and that you have an opportunity to contest the registration. Attached hereto is the Petition which includes a certified copy of the Order being registered.

You are hereby advised of the following:

1. That a registered child custody determination is enforceable as of the date of registration in the same manner as a child custody determination issued by a court of this state;
2. That a hearing to contest the validity of the registered determination must be requested

within thirty (30) days after service of notice.

3. That failure to contest the registration shall result in confirmation of the child custody determination and preclude any further contest of that determination with respect to any matter that could have been asserted.

Should you wish to contest the validity or enforcement of this registered Order, you must request a hearing no later than thirty (30) days after the date of service of this Notice of Registration by filing a motion with this Court.
