Requirements

The Minor must have an established guardianship of the minor's estate, or be simultaneously filing to establish a guardianship of a minor's estate, in Greene County Probate Court. A guardian, parent or legal custodian seeks to convert the minor guardianship into a minor trust to maintain the assets until the minor turns 25. If the Minor is 14 year or older, the Court may require a Guardian ad Litem be appointed before approving a conversion of a minor guardianship to a minor trust. (see Local Rule 66.2(H)).
